Terms of Group Enrolment

1. Registration

Course registrations are processed on a “first come, first serve” basis. Shortly after submitting your organization’s group registration form, you will receive an email confirming the group enrolment. If your organization’s registration cannot be accepted for any reason (e.g. venue capacity limits), you will be notified by email and your organization will be issued a full refund if it has already paid.

2. Course Materials

Each Enrollee covered by your organization’s group registration form will be furnished with a hard copy of the course materials during his or her attendance at the course. Shortly after the course, he or she will also receive a pdf copy of the course materials via email.

3. Cancellation & Partial Refund

The cancellation deadline date is the date that precedes the course date by five business days. If, in respect of any or all Enrollees covered by this group registration form, your organization delivers notice of cancellation via email to Clayton Bangsund at clayton.bangsund@juliuserwin.com on or before the cancellation deadline date, the organization will receive a refund less a \$50 administration fee. The refund will be calculated with reference to group enrolment pricing. For example, if your organization initially registers and pays for eight enrollees, and then on or before the cancellation deadline date cancels enrolment for two of those enrollees, the refund will be calculated as the difference between the Group Enrolment Price for eight Enrollees and the Group Enrolment Price for six Enrollees, less a \$50 administration fee.

4. Non-Compliance, Non-Attendance & Forfeiture

Subject to Section 5, after the cancellation deadline date, enrolment cancellations will not be honoured and requests for refunds will be refused. Failure to comply with these terms governing cancellation will result in forfeiture of your organization’s entire enrolment fee. Non-attendance does not constitute cancellation.

5. Positive Covid Test Result

If any Enrollee covered by this group registration form tests positive for Covid after the cancellation deadline date and before the date of scheduled course delivery, such Enrollee must not attend the course. If documentary evidence of the Enrollee’s positive test result is furnished, your organization will be eligible for a rateable refund in relation to the Enrollee in question.

6. Substitution

Enrollee substitutions will be accepted.
