## Terms of Enrolment

### 1. Registration

Course registrations are processed on a “first come, first serve” basis. Shortly after submitting your online registration or mailing your paper registration, you will receive an email confirming your enrolment. If your registration cannot be accepted for any reason (e.g. venue capacity limits), you will be notified by email and issued a full refund if you have already paid.

### 2. Course Materials

As either a Base Enrollee or a Deluxe Enrollee, you will be furnished with a hard copy of the course materials during your attendance at the course. Shortly after the course, you will also receive a pdf copy of the course materials via email.

### 3. Book

As a Deluxe Enrollee, you will additionally be furnished with a copy of *Bangsund on the Personal Property Security Act: The CCPSL Model* (Toronto: Thomson Reuters, 2021) during your attendance at the course.

### 4. Cancellation & Partial Refund

The cancellation deadline date is the date that precedes the course date by five business days. If you deliver notice of cancellation via email to Clayton Bangsund at [clayton.bangsund@juliuserwin.com](mailto:clayton.bangsund@juliuserwin.com) on or before the cancellation deadline date, you will receive a refund less a \$50 administration fee.

### 5. Credit for Future Course

*a. Election for Credit.* As a cancelling Enrollee, instead of receiving a partial refund, you may elect to receive a full credit for enrolment in any future offering of the course, or alternatively, another course with an enrolment price of equal or lesser value. You may also apply your credit toward partial payment of the enrolment price for any future course with a higher enrolment price than the course from which you have cancelled.

*b. Course Materials in the Event of Election for Course Credit.* If, as a cancelling Base Enrollee, you elect to receive credit for enrolment in a future course, a pdf copy of the course materials will be emailed to you shortly after the date of scheduled course delivery. If, as a cancelling Deluxe Enrollee, you elect to receive credit for a future course, then your copy of *Bangsund on the Personal Property Security Act: The CCPSL Model* (Toronto: Thomson Reuters, 2021), along with a hard copy of the course materials, will be mailed to you shortly after the date of scheduled course delivery, and you will also receive a pdf copy of the course materials via email. For greater certainty, you will not receive an additional book at the future course you attend unless you pay an additional \$130 + tax. However, just as any Base Enrollee, you will receive hard and digital copies of the course materials at your choice of future course.

*c. Cancelling Enrollee’s Election.* In your cancellation email, please indicate your election to receive credit for enrolment in a future course offering. If you do not specify an election for course credit in your cancellation email, you will be deemed to have elected to receive a partial refund pursuant to Section 4.



## **6. Non-Compliance, Non-Attendance & Forfeiture**

Subject to Section 7, after the cancellation deadline date, enrolment cancellations will not be honoured and requests for refunds will be refused. Failure to comply with these terms governing cancellation will result in forfeiture of your entire enrolment fee. Non-attendance does not constitute cancellation.

## **7. Positive Covid Test Result**

If you test positive for Covid after the cancellation deadline date and before the date of scheduled course delivery, do not attend the course. If you furnish documentary evidence of your positive test result, you will be eligible for a full refund or course credit as outlined in Section 5, whichever you elect.

## **8. Substitution**

Enrollee substitutions will be accepted.
